

Participant Requirements and the Assumption of the Risk and Waiver of Liability Relating to Coronavirus/Covid-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact, including individuals without disease symptoms. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited or limited the congregation of groups of people.

The health and well-being of our staff and Participants remains our top priority. In order to minimize the risk of COVID-19 entering our environment and spreading amongst our community, we will only allow staff assigned to work and Participants scheduled to participate to be in our facilities. Parents wishing to remain on site can use outdoor common areas or the parking lot to wait for their Participant(s). Participants waiting to attend a session will need to wait outside while maintaining social distance from others.

MAVA, LLC; MidAmerica Sports Center, LLC and RPG, LLC (hereafter referred to as the "Club") has put in place numerous preventative measures and enhanced cleaning protocols to reduce the likelihood of spreading COVID-19 in Club's facilities environment; however, the Club cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending sponsored activities at the Club could increase your risk and your child(ren)'s risk of contracting COVID-19.

Furthermore, all Participants in sponsored activities at CLUB must agree to and abide by the following:

Athletes, Coaches/Trainers (herein after all may be referred to as Participants) Expectations

- Participants must adhere to the illness policy stated below under Entry Testing Procedures
- Participants must be temperature/health checked upon arrival
- Coaches must wear masks while coaching
- Participants must maintain social distances per CDC recommendations
- Participants must abide by all Facility Guidelines posted throughout the Facility
- Participants must practice proper hand washing / sanitizing after contacting surfaces inside the building and after each training session
- Participants must be logged in for contact tracing purposes upon entering building
- Participants must refrain from any physical touching of all other Participants
- Participants must wear a face mask upon entering and leaving the building, but not during athletic activity
- Participants must bring personal water bottle and any required equipment, storing such equipment in accordance with social distancing policies
- Participants must maintain social distancing when taking water breaks and receiving instructions

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily agree to the participation terms described above and assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending the Club and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

I understand that the risk of becoming exposed to or infected by COVID-19 at the Club may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Club employees, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at the Club or participation in Club programming ("Claims").

On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the Club, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Club, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Club activity.
